3. Healthcare Learners Coronavirus Advice Guide

A new <u>Healthcare Learners Coronavirus Advice Guide</u> has been uploaded to the HEE Covid-19 pages today.

The guide is a resource for healthcare learners to access information on keeping safe at work and in wider life during the Covid-19 pandemic. Produced by two of HEE's Clinical Fellows, Raees and Vidushi, the document contains practical advice on how learners can keep safe at work, while on public transport, how to protect those who they live with and self-care/wellbeing.

- 5. New strategic vision highlights important role of simulation and immersive technologies with health and care

Health Education England's (HEE) Technology Enhanced Learning (TEL) team has published a national strategic vision for simulation and immersive technologies in health and care. This vision explores how simulation-based programmes can help enhance education, clinical practice and staff wellbeing within the health and care sector.

The comprehensive document looks at the application of simulation and immersive learning technologies to help address system-wide challenges that are being faced by health and care leaders. These include enhancing placement capacity, providing assurances regarding competency attainment, and supporting workforce transformation as part of the process of system redesign.

It also describes opportunities to support recruitment and selection, so that the right people are recruited into the right roles, along with promoting workforce wellbeing and lifelong learning for all staff groups.

The document is presented in several chapters as outlined below, and will offer links to case studies that provide relevant examples from literature or the UK simulation community:

- 1. Improving patient safety
- 2. Delivering a modern workforce
- 3. Enhancing the quality and capacity of the learning environment
- 4. Involving patients and the public
- 5. Developing the simulation and immersive technology community
- 6. Simulation-based research and innovation
- 7. Learning from sectors outside of health and care
- 8. Reflections on the impact of COVID-19.

The vision is intended to help inform system and organisational leaders, commissioners, regulators, professional bodies, public and patient representatives, and academic and industry partners.

<u>A suite of additional documents</u> has been produced alongside the vision including national guidance on the safe delivery of simulation-based education and key lessons from the initial response of the UK simulation community to the COVID-19 pandemic.

The next stage of development is an operational plan, which will focus on key areas within the vision that are priorities within health and care.

6. Quality update - Escalating Concerns

Back in April this year, the HEE Supporting and Escalating Concerns in Clinical Learning Environments during COVID-19 guidance was shared to ensure that all students, trainees and learners were informed of how they can raise any concerns related to their clinical learning environment via their professional/educational networks.

We are aware that the number of COVID-19 cases within the region are increasing and placing pressure upon trusts. Therefore, we want to ensure that all trainees/learners are aware of the process for them to escalate any concerns they may have. In the case of significant or urgent concerns which have not been possible to resolve using local or usual routes, trainees can contact their local HEE Quality team directly via the emerging concerns email for all learners as follows:
