

ARCPs

Nine months has gone since our new recruits have joined in August, and quite a few have completed their first ICM ARCPs. Like other specialty ARCPs, the ICM curriculum requires trainees to demonstrate their competencies through SLEs, MSFs and HiLLO curriculum sign offs. There is considerable amount of evidence to upload in time for your ARCP, so do meet with your educational supervisor and faculty tutor to ensure ESSR sign offs are satisfactory. This is to avoid delay in ARCP outcomes affecting end of stage 1 completion and consequently affect progression to stage 2 training.

LTFT and OOP applications

We welcome all LTFT applications through the PGMDE support portal. Please be aware that a 16-week advance notice from application to date of LTFT applies to applications for parental care, disability, ill-health or other caring responsibilities; all other reasons need to be submitted within the application windows determined by your rotational dates (https://lasepgmdesupport.hee.nhs.uk/support/solutions/articles/7000018502-when-can-i-apply-for-ltft-what-is-the-notice-period-)

This is to provide the individual trusts and training programme time to plan for these changes. Of course, unforeseen emergencies do happen, and we will try our best to support trainees whenever possible, but it is very difficult to do this with little notice, so do get in touch with your respective TPD for advice and support.

All OOP can only be taken after successful completion of stage 1 ICM training.

Stage 2 placements

Everyone in programme should have a good idea what they are doing for their stage 2 specialty modules and SSY now; if not then please get it touch. We've continued to be able to offer almost everyone their first or second choice of SSY, which is brilliant, and though we realise that the specialty hospital placements can end up with a number of 3-month blocks during this year, the experience offered at those hospitals should be excellent.

To remind you, those of you who are dual with anaesthetics will have all of your stage 2 placements organised by anaesthetics and those dualling with other specialties will be with them apart from their specialty ICM placements.

FFICM timing/exams

Firstly, I'd like to echo Dr Anderson's congratulations to those who have passed the FFICM at the latest sitting and add my commiserations to those who still have parts to complete. Please do not hesitate to contact us to let us know your results (we don't get this centrally from FICM) as we may be able to help with some support. I'd also like to say (again!) that the exam is a statutory requirement to enter stage 3 ICM, this means that not getting it before your stage 3 clinical placements for standalone and anaesthetics dual (usually 12 months WTE before CCT), or before you enter stage 3 in the dual programme with other duals (usually 18 months WTE before CCT) will lead to an extension. We'll generally plan to do that extension within the post you were expecting to go to anyway and add the further required stage 3 time at the end of your programme.

ARCPs

May 2025 ARCPs, can I put out a plea to read your ARCP outcome forms, we should be letting you know when your next end of stage critical progression point is, confirming your CCT date and setting your next ARCP date. Your next ARCP has to be within 15 months and will generally be annually, it may be sooner due to end of stage timings, especially if less than full time, or end of extension reviews, but usually we will try to avoid them more frequently than every 9 months. If there is an unusually short period between ARCPs we will explain the reasoning in the outcome form ("Next ARCP in 3 months, with the exam results at the end of the Outcome 3 extension period" – for example). Please contact us if you are unsure or think we have scheduled you too early.

The ARCP forms are not a very good tool for recording ST grade, due to the fact that for any number of reasons (e.g. going LTFT) they may not fall at the time you are moving from one ST grade to another. We will do our best to make sure they are roughly right; the most important thing is that the grade is right on TIS as that's the one that determines the pay progression point!
