TPD Announcements

Stage 1 ICM TPD

Hi all, I am Dr Jenny Townsend, Consultant in ICM, Anaesthesia and Major Trauma at Kings College Hospital & your new Stage 1 TPD. I will be in touch with all stage 1 trainees soon to check we are on track. In the meantime, please email me at jenny.townsend@hee.nhs.uk if I can help.

Stage 2 & Lead ICM TPD

I'm Russ Hewson, the stage 2 ICM TPD. I'm a Consultant Intensivist and Anaesthetist at the Royal London Hospital and have been TPD for just over a year having previously been a long serving Faculty Tutor. As well as overseeing subspecialty and SSY modules I also tend to be most involved with dual training (as it generally throws up more queries in stage 2 than the other

stages) and OOPs as they are predominantly undertaken in stage 2 time. We have lots of trainees moving into stage 2 from August 2023 and I'll be emailing with your provisional placements before Christmas; it's tight from a post perspective so it has taken longer than usual to ensure that everyone gets their specialty training covered and a Special Skills Year (SSY) choice that supports their career plans. For those of you who dual train please be aware that your SSY is your partner specialty training and for those that dual with anaesthesia your stage 2 training is organised by your anaesthetic TPD and delivered from your anaesthetic training programme (with my support).

I have also recently taken on the lead TPD role, so if you have any queries regarding ICM training that cannot be answered by the HEE Operations Team through the support portal and do not neatly fit into a specific stage of training please get in touch.

My email address is russell.hewson@hee.nhs.uk and I try to put an out-of-office on for busy clinical periods and leave so you get a good feeling for how quickly I'll be responding.

Stage 3 ICM TPD

This is an exciting time for us, having our own school (London School of ICM) within the umbrella of Health Education England. I am your stage 3 Training Program Director, and my responsibility is to look after your training needs during the last year of ICM training. I work as consultant intensivist at Epsom and St Helier Hospital NHS Trust. I have been actively involved in ICM training and have had the opportunity to work as a college tutor and regional adviser (interim) in past.

I fully understand the importance of stage 3 placements, as this is the year where you are preparing to step up from a trainee to future consultant. Every year between August and September I shall be asking for stage 3 placement preferences (with ranking) from all the trainees who are transitioning to stage 2. I suggest you should rank units bearing in mind your commute needs and possible consultant post ambitions. I will aim to complete allocations by the end of the year.

It's important to be aware that the purpose of stage 3 training is to consolidate competencies, develop high level management and leadership skills, and become progressively more autonomous in readiness for consultant practice. The stage 3 curriculum is not designed to deliver subspecialty training, so placements will be in general ICU's (although some may have subspecialist patients in their normal general case-mix). If you are interested in planning a

subspecialty career, options would include undertaking the relevant Special Skills Year in stage 2 ICM (single specialty ICM training curriculum) or you could organise an out of programme (OOP)/or post CCT fellowship in your chosen area of expertise. Obviously, I shall be engaging with you all to look after your needs on a case-by-case basis.

I appreciate the value of engagement with trainees either face-to-face or virtual. ARCPs

ARCPs this year have been challenging whilst we all become more familiar with the new electronic portfolio, LLP. You will be pleased to know there are improvements in the works, which should improve the visibility of your portfolio to ARCP panels in London and hopefully reduce the number of outcome 5's (over 60% of trainees had missing/not visible evidence on some panels!). Nevertheless, please be aware of the following points which will help streamline the process further:

The Educational Supervisor Structured Report is a key document and must cover the date range from the last ARCP. All evidence (including form R) needs to be linked before it is "signed off" in order to be visible. For that reason, it should be done as the very last thing when preparing for an ARCP. At the time of writing the LLP does not automatically notify Faculty Tutors that an ESSR requires ratification so please ensure you inform your FT of an impending ARCP and ESSR (with plenty of notice!). Other guidance is available both from the faculty and the London School of ICM webpages, including a presentation that we did for the trainers to introduce the new curriculum which is still relevant.

Dual anaesthetic/ICM trainees please be aware that evidence on the anaesthetic side of the LLP cannot be seen by your ICM trainers. We have requested this but it may not happen quickly so everything will need to be evidenced and visible in your ICM portfolio.

Any issues with the LLP that can't be resolved with your local trainers would be worth raising with your TPD, whom might be able to give advice gleaned from elsewhere, or for more technical things to llp@ficm.ac.uk

Covid derogations are still with us, however at this point they are increasingly rarely utilised and almost only pertain to trainees who are already on a covid outcome for a missed module that still has not been afforded in the programme. Of course, there may be unique sets of circumstances where this is not the case and ESSR's should detail where a trainee would have progressed were it not for covid alone.

ICM ACRPs are held quarterly. The majority are conducted in January & May, but in order to streamline the process we are trying to align them with critical progression points e.g., end of stage. In general, we try to keep a 12–15-month window between ARCP's to achieve this this however rarely this will require an ARCP 6 months apart to get trainees on the right ARCP "axis". Please keep an eye out for your ARCP notification and get in contact with the HET Operations team or your TPD if you have any concerns. If you are a dual trainee, please be aware you will have an ARCP in BOTH specialities on an annual basis.

All ARCPs are in absentia and this is unlikely to change. However, it is very helpful for you to be contactable by mobile phone on the day for post ARCP feedback if needed.

Each session will have relevant expert speakers as well as an opportunity for up to three trainees to give a short, Pecha Kucha style presentation on a QIP/audit/research project relevant to the topic.

This means presentations of no more than 6 minutes and 40 seconds i.e., 20 slides with 20 seconds per slide.
